THE TITTLESHALL PARISH COUNCIL FOOTPATH REPORT FOR TUESDAY THE 19TH MAY 2025

FOOTPATH TWO has its signposted entrance on Church Lane across a bridge leading to the public right of way that runs diagonally across the field. The right of way path is clearly marked although because the field is fallow the grass crop has blurred the edges a bit. The footpath continues across and circumvents the moat to join FOOTPATH ONE which leads as a single path up to the ruins of the English Heritage Medieval village of Godwick. Halfway up this track there should be a public footpath across the field leading to the farm - but this path has not been re-instated. Alongside FOOTPATH TWO the landowner has created a permissive path which runs along the right hand margins of the field and at the top turns left to join FOOTPATH ONE.

FOOTPATH FOUR is entered opposite Manor Farm on the Fakenham Road. The plantation which replaced the fenced area used for cattle grazing has a path through which leads to the moat and joins FOOTPATH ONE.

FOOTPATH FIVE runs from Back Lane through to the farmyard of High House Farm and is clear to walk. The path then traverses the farmyard and joins with FOOTPATH SEVEN which is the old cricket pitch and the footpath there is clear to walk. The path exits at the beginning of the Stanfield Road near Peelings Coach Company.

FOOTPATH SIX is situated on the right of the Litcham Road leading out of the village and ends at the solar farm installation on the back road leading to Litcham. The first part of the public right of way track is hardcore and is frequently used by farm vehicles and by cattle when being moved to different field locations. The second part of the path

narrows to grass and has an electric fence installed which is only activated when livestock are in the field. The path itself is clear to walk but the grass is high and the hedge is beginning to encroach.

FOOTPATH EIGHT branches of Back Lane at Cokesford Cottage. The right of way is wide and clear because it is used regularly by farm vehicles.

FOOTPATH TEN is a continuation of FOOTPATH EIGHT and is clear to walk ending at the road to Mileham.

FOOTPATH ELEVEN branches off FOOTPATH EIGHT and exits further along the Mileham Road and is passable to walk.

FOOTPATH THREE is located along the Stanfield Road on the left near Wicken Farm. The entrance is over a wooden bridge, which is clear and robust, and into the field where the path is clear and wide and leads to Whissonsett. The signpost, however is leaning a bit into the hedge due to the base crumbling.

FOOTPATH NINE is also on the Stanfield Road but accessed on the right at Wicken Farm. The path is clear and wide to walk with evidence of grass cutting by tractor and would lead you to Mileham. The right of way signpost is gradually being obscured by hedge growth.
