

THE TITLESHALL PARISH COUNCIL FOOTPATH REPORT FOR TUESDAY THE 1ST OF JULY 2025

FOOTPATH TWO which has its entrance on Church Lane and over a wooden bridge that leads into the field's right of way. The footpath runs diagonally across the field and at this present time has not been reinstated. The crop is grass and the field left fallow so the growth has been undisturbed and you can pick out the rough direction but it is speculative. There is a permissive path, created by the landowner, that runs around the margins of the field on the right, but this also has grass waist high but the path is discernible. The diagonal path, when re-instated, circumvents the old moat and joins FOOTPATH ONE which leads as a single path up to the ruins of the English Heritage Medieval village of Godwick. Halfway up this track there should be a re-instated diagonal route leading up to the farm. I was not able to ascertain whether the path had been re-instated.

FOOTPATH FOUR is entered opposite Manor Farm on the Fakenham Road. The entrance is darkly wooded, but clear, and should lead down to the moat and join with FOOTPATH ONE. The plantation that the path passes through has overgrown shoulder high grasses which narrow and obscure the path substantially, so you would have to be pretty determined to walk through. I did not.

FOOTPATH FIVE runs from Back Lane through to the farmyard of High House Farm and is clear to walk and leads on to FOOTPATH SEVEN which was the Old Cricket Pitch and that has been cut and is clear to walk. The path

exits at the beginning of the Stanfield Road near Peelings Coach Company.

FOOTPATH SIX is located on the right of the Litcham Road leading out of the village and ends at the solar farm installation on the back road leading to Litcham. The first part of the path is hardcore and is used by farm machinery and cattle. The second part of the path becomes grass and has an electric fence running its length only activated when livestock is in the field. At present the grass is quite high and the over hang from the hedge is quite low so it would be hard work to try to walk the path upright.

FOOTPATH EIGHT leads off Back Lane at Cokesford Cottage. The right of way is wide and clear and is used regularly by farm vehicles.

FOOTPATH TEN is a continuation of FOOTPATH EIGHT and is a clear walk ending at the Mileham Road.

FOOTPATH ELEVEN branches off FOOTPATH EIGHT and is passable to walk and exits onto the Mileham Road.

FOOTPATH THREE is located along the Stanfield Road on the left near Wicken Farm. The entrance is over a robust wooden bridge and into a field where the path is navigable albeit with high weeds and would lead you to Whissonnsett.

The public right of way signpost looks like it has been re-potted and stands upright and proud.

Which is more than can be said for FOOTPATH NINE which still has a signpost leaning on the hedge for support. The

path however is wide and well cut and clear to walk
Mileham
